## Johnson County Board of Commissioners January 16, 2024

The Johnson County Board of Commissioners met in regular session on Tuesday January 16, 2024 County Commissioners present were Ted Evans District 2, David Borrenpohl District 1, Les Agena District 3.

The meeting was called to order Chairman Evans at 8:15 A.M.

The Pledge of Alliance was recited by all in the room.

Chairman Evans acknowledged that the open meetings act was posted by the entrance of the Johnson County Board Room.

Emergency Manager Megan Buckley indicated to the board that she had reached out to NEMA to see if there were any funds available to help with snow removal, and the answer was there were no funds available. Also discussed were snow removal procedures.

Highway Supt. Matt Schaardt talked about the snow removal, and to ask what the board thoughts are about hiring someone to assist with clearing out snow drifts. No decision was made.

Sheriff Josh Sterkel reported to the board that his 2015 Chevrolet pickup needs repairs. Also discussed was extending the step program out for the Deputies, and the Dispatchers.

Mary Kent Johnson County Hospital Administrator, Brandon Willey, and Austin Partridge discussed the Renovation and expansion project for the Johnson County Hospital, and bonding options.

Jerry Berggren, Aaron Wubbels, Mark Riley, and Rick Wintermute with Kingery Construction were present at the meeting to discuss the Courthouse Roof Project. Discussions were held on what type of covering to go Asphalt Shingles or Copper, after discussion that asphalt shingles will only last approx. 25 years and the Synthetic Slate will last approx. 50 years it made more sense to go with the copper which should last over 100 years, and that there was not a lot of difference in price.
