# Johnson County Board of Commissioners January 17, 2023

The Johnson County Board of Commissioners met in regular session on Tuesday January 17, 2023 County Commissioners present were, David Borrenpohl District 1, Ted Evans District 2, and Les Agena District 3.

Kathleen M. Nieveen County Clerk is recording the minutes.

County Clerk Nieveen called the meeting to order at 8:15 a.m. to disband the current County Board.

Clerk Nieveen called for nominations for the 2023 Johnson County Board Chairman position.

A motion was made by Agena and was seconded by Borrenpohl to approve Resolution 23-02 a Resolution for the re-classification of road from Minimum Maintenance to Local Status The road being located 615 Avenue and 722 Road. Yeas: Borrenpohl, Agena, Evans, Nays; none motion carried.

County Sheriff Byron Klauenberg was present to give the board on calls made the first part of January, Also discussed were the purchase of new Radios, and telephone Lines

Representatives from South O Roofing were present at the meeting to give the board a report on the condition of the Courthouse Roof. The board thought it would be a good idea if they would come back in 2 weeks when the architect was here so that they could get more information.

The board acknowledged the 2023 Mileage Reimbursement Rate effective January 1, 2023 to be .655 per mile.

The Johnson County Board of Commissioners adjourned the meeting at 12:15 P.M. The board will meet again in regular session on Tuesday January 31, 2023 at 8:15 A.M. All board meetings are open to the public; the agenda is being kept current and available at the County Clerk's Office.
