## Johnson County Board of Commissioners January 19, 2021

The Johnson County Board of Commissioners met in regular session on Tuesday January 19, 2021 County Commissioners present were Scotty Gottula District 1, Ted Evans District 2 and James Erickson District 3.

Kathleen M. Nieveen County Clerk is recording the minutes.

Chairman Erickson declared the meeting open at 8:19 A.M.

Chairman Erickson acknowledged that the open meetings act was posted on the wall by the entrance of the County Boardroom.

Notice of the Johnson County Commissioner's meeting was sent to each post office in Johnson County, it was posted on the Johnson County Website at johnsoncounty.ne.gov and was sent to the Tecumseh Chieftain on Friday January 15, 2021.

A motion was made by Evans and was seconded by Erickson to nominate Scotty Gottula as Chairman of the Johnson County Board of Commissioners for 2021. Yeas: Evans, Erickson, Nays none abstain Gottula

A motion was made by Evans and was seconded by Gottula to nominate Jim Erickson as Vice-Chairman of the Johnson County Board of Commissioners for 2021. Yeas: Gottula, Evans nays; none abstain Erickson, motion carried.

A motion was made by Gottula and was seconded by Erickson to nominate Ted Evans as Chairman of the Johnson County Board of Equalization for 2021. Yeas: Gottula, Erickson, Nays none abstain Evans. Motion carried.

A motion was made by Evans and was seconded by Gottula to nominate Jim Erickson as Vice Chairman of the Johnson County Board of Equalization for 2021. Yeas: Evans, Gottula, Nays none abstain Erickson motion carried.

A motion was made Evans and was seconded by Erickson to post the County Board agenda's in the local post offices, Courthouse and on the Johnson County web-site. Yeas: Evans, Gottula, Erickson, Nays; none motion carried.

Amotion was made by Evans and seconded by Erickson to designate the Tecumseh Chieftain as the Johnson County Official newspaper for 2021. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

A motion was made by Evans and was seconded by Erickson to approve Resolution No. 21-02 a resolution approving and designating the following banks as depositories for County funds: American National Bank, Mainstreet Bank, Tecumseh Federal Bank and NPAIT. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

Emergency Manager Amanda Burki presented the board with a Covid-19 update, and discussed with the board the vaccines for Covid-19. The board will discuss with the Johnson County Hospital Administrator about the vaccines at the next board meeting.

Highway Supt. Matt Schaardt presented the board the resolution for the Mitigation Plan with the NRD.

A motion was made by Evans and was seconded by Erickson to approve Resolution No. 21-01 a Resolution for the Nemaha Natural resources Hazard Mitigation Plan 2020. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

Matt also informed the board that Dan Alexander has completed the bridge inspections and would like to meet with the board at a later date to inform the board on what other types of work he can do for the county.

The one- and six-year road hearing has been set for February 16, 2021 at 9:15 A.M.

Matt informed the board that he has a meeting with Manile Wager later this week and he will try to find out when the Robison Bridge will start.

The board discussed the steps on the East and Southside of the Courthouse located at the street. The board thought that the Southside was worse than the East sided, therefore they thought the main focus should be replacement of the southside steps. Matt informed the board that he and Rex have looked at the steps located by the street on the Southside of the Courthouse. Matt told the board that the Road Department will help with removal of the existing steps but are not able to help with the replacement.

At 9:15 A.M. Fuel bids were opened and placed on file in the County Clerk's Office. Only one bid was received and that was from G & G Oil Company. A motion was made by Evans, and was seconded by Erickson to approve the bid from G & G Oil Company as follows:

Tecumseh Shop Unleaded with 10% Ethanol \$1.919, Diesel Low Sulfur #1on Road \$2.429, and #2 on Road \$2.179 Cook, Crab Orchard, Elk Creek and Sterling Shop Diesel Low Sulfur off Road \$2.079, #2 off Road \$1.829. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

The board acknowledges the Johnson County Treasurer receipt in the amount of \$1,529.42 from the Nebraska Department of Environment and Energy for the additional payment to Johnson County to cover extra costs incurred from the scrap tire cleanup event held in 2020.

The board acknowledges the Johnson County Treasurer Semi-Annual Statement from July 1, 2020 to December 31, 2020.

The board received the Johnson County Sheriff's office balance sheet as of December 31, 2020.
