Johnson County Board of Commissioners October 25, 2022

The Johnson County Board of Commissioners met in regular session on Tuesday October 25, 2022 County Commissioners present were, Robert Curry District 1, Ted Evans District 2, and James Erickson District 3.

Kathleen M. Nieveen County Clerk is recording the minutes.

Vice Chairman Erickson declared the meeting open at 8:15 A.M.

Vice Chairman Erickson acknowledged that the open meetings act was posted on the wall by the entrance of the County Boardroom.

Notice of the Johnson County Commissioner's meeting was sent to each post office in Johnson County, it was posted on the Johnson County Website at johnsoncounty.ne.gov and was sent to the Tecumseh Chieftain on Friday October 21, 2022.

AGENDA: A motion was made by Evans and was seconded by Curry to approve the agenda. Yeas: Evans, Curry, Erickson, Nays; none motion carried.

MINUTES: A motion was made by Curry and was seconded by Evans to approve the minutes of the October 11, 2022 board meeting. Yeas: Curry, Evans, Erickson, Nays: none Motion Carried.

A motion was made by Evans and was seconded by Curry to authorize the County Treasurer to transfer \$250,000.00 from General Fund to Road Fund. Yeas; Evans, Curry, Erickson, Nays; none motion carried.

Emergency Manager Amanda Burki gave the board a report on the fires that occurred on Sunday in Pawnee County because of the high winds. No fires were reported in Johnson County.

Also discussed was the GEO Com Mapping Software for addressing. Amanda will contact PSC to see if the E 9-1-1 set aside funds could be used for this upgrade.

At 8:30 A.M. the fuel bids were opened and placed on file in the County Clerk's office. Only one bid was received. A motion was made by Evans and was seconded by Curry to approve the bid from Gottula Propane Service Inc. as follows:

Tecumseh Shop, Unleased with 10% Ethanol \$3.199, Diesel Low Sulfur #1 on Road \$5.049, Diesel Low Sulfur #2 on Road \$4.749,

Cook, Crab Orchard, Elk Creek and Sterling Shop Diesel Low Sulfur #1 off Road \$4.799, Diesel Low Sulfur #2 off Road \$4.499. Yeas: Evans, Curry, Erickson nays; none motion carried.

Highway Supt. Matt Schaardt discussed with the board the possible road build up on 722 west from 615 Ave. to take it off of minimum road classification. Matt had a quote on an approximate cost of the road build up to classifications. No decision was made.

He also reported that the cost for the fuel system from Yant will be \$22,604.84 and will proceed with the updates needed.

Bid letting was held on Project C49-299 and C49-300. Bids were received from Gana Trucking and Excavating Bauer Infrastructure LLC, BAB Inc, Husker Engineering, Tim Sisco Construction LLC, and Vogt Scapes Inc.

A motion was made by Curry and was seconded by Evans to approve the bid from Husker Engineering for Project C49-299 \$30,136.00, and Project C49-300 \$37,403.00, with construction to begin December 2022 with weather permitting. Yeas: Evans, Curry, Erickson, Nays; none motion carried.

Sheriff Byron Klauenberg reported that he has hired 2 dispatchers, and that he has ordered 2 new vehicles, and explained that the vehicles will probably not get here until the end of the budget year. He also explained the reason he ordered 2 was he could lock in the price.

Ken Mandl was present to discuss with the board the replacement for Board member Don Doeden who passed away October 2, 2022. One name was brought forward for consideration.

A motion was made by Evans and was seconded by Curry to approve the recommendation of Mike Carman for Cook Legion Post #360 Representative to the Johnson County Veterans Service Board. His term will expire June 30, 2026. Yeas: Evans, Curry, Erickson, Nays; none motion carried.

Derek Gottula representative for Brinkman Brothers Inc. discussed with the board the possibility of placing a car charging station on the SW corner of the Courtyard. Derek said that GM contacted them about putting a car charging station in Tecumseh, they also indicated that GM would pay the cost of the station. The board would like to have them look at other sites before the board would commit to the location. A concern about the location of the station if it would interfere with the Avenue of Flags.

Jerry Berggren discussed with the board the exterior conditions of the courthouse and the approx. cost for renovation.

A motion was made by Curry and was seconded by Evans to approve Resolution 22-25 a Resolution for the Subdivision of the SW ¼ SW ¼ of Section 20 Township 6 Range 9. Yeas: Evans, Curry, Erickson, Nays; none; motion carried.

A motion was made by Evans and was seconded by Curry to authorize NIRMA to represent Johnson County in District Case CI22-3020. Yeas: Evans, Curry, Erickson, Nays; none motion carried.

A motion was made by Evans and was seconded by Curry to authorize the County Clerk to cancel Check 22080017 made payable to Eakes Office Solution in the amount of \$84.50 as the item purchased was returned, and check NO. 22090094 made payable to Damme Appliance in the amount of \$75.00 as this was a duplicate payment.
