# Johnson County Board of Commissioners February 16, 2021

The Johnson County Board of Commissioners met in regular session on Tuesday February 16, 2021 County Commissioners present were Scotty Gottula District 1, Ted Evans District 2 and James Erickson District 3.

Kathleen M. Nieveen County Clerk is recording the minutes.

Chairman Gottula declared the meeting open at 8:18 A.M.

Chairman Gottula acknowledged that the open meetings act was posted on the wall by the entrance of the County Boardroom.

Notice of the Johnson County Commissioner's meeting was sent to each post office in Johnson County, it was posted on the Johnson County Website at johnsoncounty.ne.gov and was sent to the Tecumseh Chieftain on Friday February 12, 2021.

AGENDA: A motion was made by Evans and was seconded by Erickson to approve the agenda. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

MINUTES: A motion was made by Erickson and was seconded by Evans to approve the minutes of the February 2, 2021 board meeting. Yeas: Evans, Erickson, Gottula, Nays; Motion Carried.

Emergency Manager Amanda Burki gave the Covid-19 update and discussed Disaster 4420 March 2019 Flooding Project update, and the Cares Act funding.

The board recessed at 8:29 A.M. to finish up the board of Equalization meeting.

The board reconvened at 8:41 A.M.

County Attorney Rick Smith discussed with the board the contract with Windstream for the phone system. Rick indicated that he feels like it is the same contract as in other years and this contract is from March 1, 2021 through March 1, 2022.

A motion was made by Evans and was seconded by Erickson to approve the contract with Windstream for maintenance of the phone system at the County Sheriff's office. Yeas: Erickson, Evans, Gottula, Nays; none motion carried.

Kelly Kuhl Johnson County Road Sec. was present at the meeting to give the board an update on Road projects

Fuel bids were opened at 9:15 A.M. and placed on file in the County Clerk's Office. The board received one bid from Gottula Propane Service Inc for a one month bid and six-month bid.

A motion was made by Erickson and was seconded by Evans to approve the 6-month bid from Gottula Propane Service Inc. as follows:

At 9:15 A.M. the One- and Six-Year Road Plan hearing was opened. The board reviewed the projects listed on the plan.

The hearing was closed at 9:30 A.M.

A motion was made by Erickson and was seconded by Evans to approve Resolution No. 21-05 a Resolution Accepting and Adopting the One- and Six-Year Plan for Road Improvement for Johnson County, Nebraska. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

Kathleen Nieveen County clerk discussed with the board LB102 this bill would be the consolidation of the District Court functions with County Court.

Austin Partridge from First National Capital Markets, Mary Kent CEO and Reba Burgett CFO Johnson County Hospital were present at the meeting to discuss the redemption of the General Obligation Bonds Series 2016 Bond and the issuance of the General Obligation Refunding bonds.

A motion was made by Evans and was seconded by Erickson to authorize the calling for early redemption of the County's outstanding General Obligation Bonds Series 2016, date of original issue December 29, 2016 in the principal amount of \$1,665,000.00, and to approve authorizing the issuance by Johnson County of not to exceed \$2,000,000.00 aggregate principal amount of General Obligation Refunding Bonds, Series 2021, for the purpose of refunding the County's outstanding General Obligation Bonds, Series 2016, date of original issue-December 29, 2016. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

A motion was made by Erickson and was seconded by Evans to cancel Check 20110101 issued to Steven D. DeFreece for Jury Duty Service upon his request. Yeas: Erickson, Evans, Gottula, Nays; none motion carried.

A motion was made by Erickson and was seconded by Evans to approve the board appointment for 2021. Yeas: Evans, Erickson, Gottula, Nays; none motion carried. A Complete list is on file in the County Clerk's office.

Commissioner Evans reported to the board that there is a sewer problem at the Sheriff's Office in the upstairs which need repairs, and that Moran can fix the problem. The board decided to have Moran fix the problem.
