# Johnson County Board of Commissioners March 15, 2022

The Johnson County Board of Commissioners met in regular session on Tuesday March 15, 2022 County Commissioners present were, Scotty Gottula District 1, Ted Evans District 2 and James Erickson District 3.

Kathleen M. Nieveen County Clerk is recording the minutes.

Chairman Gottula declared the meeting open at 8:15 A.M.

Chairman Gottula acknowledged that the open meetings act was posted on the wall by the entrance of the County Boardroom.

Notice of the Johnson County Commissioner's meeting was sent to each post office in Johnson County, it was posted on the Johnson County Website at johnsoncounty.ne.gov and was sent to the Tecumseh Chieftain on Friday March 11, 2022.

AGENDA: A motion was made by Evans and was seconded by Erickson to approve the agenda. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

MINUTES: A motion was made by Erickson and was seconded by Evans to approve the minutes of the March 1, 2022 board meeting. Yeas: Evans, Erickson, Not Voting Gottula, Nays; Motion Carried.

Highway Supt. Matt Schaardt presented a Resolution for the County Bridge Match Program.

A motion was made by Erickson, and was seconded by Evans to approve Resolution #22-08 A Resolution that the Chairman of the Johnson County Board of Commissioners is hereby authorized to sign the Project Program Agreement between Johnson County and the NDOT for Project County Bridge Match Program. Yeas: Evans, Erickson, Gottula, Nays none motion carried.

Matt discussed the Resolutions for setting the public hearings for 2 county road closures are not ready yet for approval Matt is awaiting the legal descriptions of the County Roads from the County Surveyor.

Discussion on motor graders was held. Matt is having the John Deere Rep and the CAT Rep look at the Counties 2011 and 2013 Motor Graders to see what kind of a trade in value the county would be looking at. Matt is looking at replacement and informed the board that the State Bid is good until the end of June.

At 8:50 A.M. fuel bids were opened and placed on file in the County Clerk's Office. Only one bid was received. A motion was made by Evans and was seconded by Erickson to approve the Bid from Gottula Propane Service Inc. Tecumseh Shop unleaded with 10% Ethanol \$3.649, Diesel Low Sulfur #2 on Road \$4.299 Cook, Crab Orchard, Elk Creek, and Sterling Shops Diesel Low Sulfur #2 off Road \$3.999. The board discussed the Re-application of the Village of Sterling for ARPA Funds. After consideration a motion was made by Erickson, and was seconded by Evans to accept the re-submitted application from the Village of Sterling being contingent for the next round of funding. The Clerk of the District Court Fee Report for February, 2022 was acknowledged.

The board discussed the approval of the 3 sections of the Courtyard to be used for an Easter Egg hunt on April 9<sup>th</sup> sponsored by the Chamber.
