The board discussed the FEMA Funds for the county and which budget they should be receipted to when received.

The board decided that all future FEMA money be credited to the fund where it needs to go which will change the decision done at the July 7, 2020 Board meeting where all FEMA money is to be credited to Inheritance Tax fund until it could be determined which fund it needs to go to.

A motion was made by Erickson and was seconded by Evans to create Fund 2580 with money to be place in lineitem Revenue code 339.25 American Rescue Plan Act. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

A motion was made by Evans and was seconded by Erickson to transfer \$350,000.00 from County General to the County Road Fund. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

A motion was made by Erickson and was seconded by Evans to approve Resolution 21-07 a resolution to transfer \$250,000.00 from County Inheritance Tax to County Road. Yeas: Evans, Erickson, Gottula, Nays; none motion carried. This transfer was decided and approved at the budget hearing to buy down the tax rate for 2020-2021.

The Board acknowledges the Johnson County Sheriff's Balance sheet as of February 28, 2021.

The board had a discussion on the Ambulances and transfers.

The Johnson County Board of Commissioners adjourned the meeting at 10:10 A.M. The board will meet again in regular session on Tuesday March 30, 2021 at 8:15 A.M. All board meetings are open to the public; the agenda is being kept current and available at the County Clerk's Office.
