Chairman Evans opened the public hearing on the one- and six-year road plan at 9:04 A.M.

The board reviewed the plan with Highway Supt. Schaardt.

Chairman Evans closed the public hearing at 9:11 A.M.

A motion was made by Agena and was seconded by Borrenpohl to accept and adopt the Johnson County Oneand Six-year Road plan. Yeas; Agena, Borrenpohl, Evans, Nays; none motion carried. Highway Supt. Schaardt also informed the board that the County Bridge Match project did not get priority.

Discussion on the City ponds at the fairgrounds was discussed. Matt has been asked for help from the county with dirt building for a trap shooting area. The board thought that they should contact the City and the Fair board first.

Chairman Evans opened the hearing on the Special Use Permit filed by RDJ Auto Sales in Section 25-6-10. Danny and Artis Fisher were present. Danny informed the board of the nature of the business.

Chairman Evans closed the hearing at 9:43 A.M.

A motion was made by Agena and was seconded by Borrenpohl to approve the Special Use Permit. Yeas: Agena, Borrenpohl, Evans, Nays; none motion carried.

Austin Partridge Director, Public Finance FNCM was present at the meeting to discuss bond structure and interest rates, and to explain how this process works.

A motion was made by Agena and was seconded by Borrenpohl to go into closed session at 10:15 A.M. Yeas: Agena, Borrenpohl, Evans, Nays; none motion carried.

The purpose of the closed session was to review the recommendation from the Grievance Board

A motion was made by Agena and was seconded by Evans to accept the recommendation of the Grievance Board findings. Yeas; Agena, Evans, Nays; none Abstain: Borrenpohl, motion carried.

The board discussed doing split shifts at the Road Department. A motion was made by Borrenpohl and was seconded by Agena to do split shifts at the Road Department. Yeas; Agena, Borrenpohl, Evans, Nays; none motion carried.

A motion was made by Evans to decrease staffing by one employee in the Road Department. Motion failed for lack of a second.

The board discussed Rock and if the board wanted to purchase more rock from another fund because the Rock budget is almost at the allotted amount out of this year's budget. No decision was made.

A motion was made by Borrenpohl and was seconded by Agena to approve the contract between Johnson County and Berggren Architects for the Exterior Restoration project. Yeas; Agena, Borrenpohl, Evans, Nays; none motion carried.

The board acknowledged the Return of Sale Proceedings from the Johnson County Treasurer the list is all of the parcels in Johnson County that were sold by the County Treasurer for delinquent real estate taxes.
