Javier Fernandez President and CEO for OPPD was present to give the board an update.

County Sheriff Byron Klauenberg, and representatives from Sterling Fire were present at the meeting to ask the board for help through ARPA funds for hand held radio's, the radios which they currently have are outdated and do not work all the time. No decision was made.

Sheriff Klauenberg also informed the board of his new hires, the new vehicle, and that all of the old guns are sold.
