Matt Schaardt gave the road report and reviewed the budget.

Sara Williamson and Regina Doty were present at the meeting for the discussion on ARPA funds. They are requesting these funds because they were closed during the Covid pandemic and had no revenue coming in, and they had continuing obligations that they still needed to pay. A motion was made by Curry and was seconded by Evans to support the Johnson County Nebraska Historical Society Inc. in the amount of \$16,000.00 out of the ARPA funds. Yeas: Curry, Evans, Erickson, Nays; none motion carried.

Chris Stone brought 2 bids to the board for the replacement of the Furnace in the County Jail. Bids were received from Moran Plumbing & Heating, and Borrenpohl Plumbing & Heating.

A motion was made by Evans and was seconded by Curry to approve the bid from Borrenpohl Plumbing & Heating for a Goodman 80,000 BTU Furnace for the Johnson County Jail in the amount of \$9,500.00 Yeas: Evans, Curry, Erickson, Nays; none motion carried.

The board was given the Johnson County Sheriff Office Balance sheet as of July 31,2022.

The board discussed the FY 2022-23 Johnson County Budget and Wages. This will be addressed again at the next meeting.

The Johnson County Board of Commissioners adjourned the meeting at 11:50 A.M. The board will meet again in regular session on Tuesday August 30, 2022 at 8:15 A.M. All board meetings are open to the public; the agenda is being kept current and available at the County Clerk's Office.
