A motion was made by Borrenpohl, and was seconded by Agena to approve Resolution 23-20 a Resolution to close the Road Department Petty Cash Fund. Yeas: Agena, Borrenpohl, Evans, Nays; none motion carried.

Chris Stone talked to the board about the south sidewalk that needs some repairs. The board is wanting to wait because they thought that the Downtown Revitalization Project was going to start soon. He also discussed the flag holders in the Courtyard that are sinking into the ground and need some work, and the extra battery powered Snow Blower that the county owns he would like the board to consider getting rid of that. The board was ok with it.

Matt Kasik CEO from Region V was present at the board to discuss the change of name of Region V Community Human Services to Apace.

A motion was made by Borrenpohl and was seconded by Agena to approve the Resolution to change the name of Region V Community Human Services to Apace. Yeas: Agena, Borrenpohl, Evans, Nays; none motion carried.

A motion was made by Borrenpohl and was seconded by Agena to approve the Dispatch Agreement between Johnson County and Pawnee County in the amount of \$28,000.00 to be collected from Pawnee County. Yeas; Agena, Borrenpohl, Evans, Nays; none motion carried.

Chairman Evans opened the budget hearing at 9:15 A.M. Terry Keebler budget preparer gave the board some statistics on the proposed budget. Bruce Williamson asked the board questions on the proposed budget, and Ken Mandl discussed his budget with the board as well.

Chairman Evans closed the public hearing at 9:56 A.M.

A motion was made by Borrenpohl and was seconded by Agena to approve the proposed 2023-2024 Johnson County Budget. Yeas: Agena, Borrenpohl, Evans, Nays; none motion carried.

Keith A. Marvin, and John C. Shepard with Marvin Planning Consultants and Mike Davison Zoning Adm. were present at the meeting to discuss updating the Johnson County Comprehensive Plan which was adopted in January 2001.

A motion was made by Borrenpohl and was seconded by Agena to approve signing an agreement with Marvin Planning Consultants to update the Johnson County Comprehensive Plan for a cost of \$43,000.00. Yeas: Borrenpohl, Agena, Evans, Nays; none motion carried. The cost of the update comes out of inheritance tax funds.

The board held a conference call with Jerry Berggren on the Courthouse renovation project.

The board received the County Sheriff's Office Balance Sheet as of August 31, 2023.

The board acknowledged the following inventories for 2023-2024: County Assessor, County Attorney, County Board, Child Support, County Clerk, County Court, Election Equipment, Emergency Manager, Extension Unit, Maintenance, County Treasurer, Veterans Service, County Roads, Probation.
