Michael Clancy and Don Brown Representatives from Renodry USA were present to discuss with the board the process of drying out the moisture in the Courthouse walls. They informed the board that they will do a free inspection of the outside walls of the Courthouse for moisture. If they find moisture, they will send a proposal down for them to consider.

Aaron Wubbels with Weathercraft presented the board with a proposal to do tuckpointing. According to the proposal when the downspouts are removed, they will install copper liners into the 8 masonry pockets, then the new downspouts will be installed. Each downspout they will installed heat cables, Masonry tuckpointing work will be the lower 10' of stone, and will include the columns at all four entries.

A motion was made by Erickson and was seconded by Evans to approve the bid from Weathercraft. Yeas: Evans, Erickson, Gottula, Nays; none motion carried.

The board discussed the bid from Mannschreck for the tuckpointing of the wing wall. At the August 31st meeting
a motion was made to approve the bid from Mannschreck to do the North side of the courthouse. When
Mannschreck was informed that he was awarded the bid to do only one side he declined the bid.
