Public notice is hereby given to the qualified electors of Gage County School District 0034 (Freeman Public Schools) in the State of Nebraska (the “District”) that at a special election to be held in said District on Tuesday, March 11, 2025, there shall be submitted to the qualified electors of the District the following proposition:

“Shall Gage County School District 0034 (Freeman Public Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed \$26,910,000 for the purposes of financing the costs of (i) certain renovations to the District’s existing school building, including renovations to the kitchen, West entrance, commons, and certain classrooms, (ii) constructing one or more additions to the District’s existing school building and related site improvements, including a career and technical education addition, and a classroom and preschool addition, and (iii) purchasing certain necessary equipment, furniture and apparatus for such renovations, buildings and additions; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?”

Qualified electors voting in favor of said proposition shall blacken the oval opposite the words “FOR said bonds and tax” following said proposition, and qualified electors voting against said proposition shall blacken the oval opposite the words “AGAINST said bonds and tax” following said proposition.

ELECTION BY MAIL:

By Mail Election

This election will be an election by mail. Each registered voter residing within the District will receive a ballot by mail at his/her address as it appears on the voter registration register; and therefore no polling places will be open for voting. Ballots will be mailed by the County Clerk or Election Commissioner on or near February 17, 2025, and before February 28, 2025. Registered voters wishing to vote in the Special Election who will be absent from their residence between February 7, 2025 and March 11, 2025 may contact their County Clerk or Election Commissioner’s Office.

Voter Registration Deadlines

1. February 21, 2025 is the last day for mail-in registrations, registrar registrations, delivered registrations and agency registrations.
2. February 28, 2025 at 6:00 p.m. is the last day for in-person voter registration in the office of the County Clerk or Election Commissioner.

Any voter who changes information on a current registration or registers to vote after the ballots have been mailed but before the in-person registration deadline of February 28, 2025 by 6:00 p.m., will be given a ballot at the time of registration or change.

Ballot Return Deadline

Voted ballots that are sealed in the “Return Identification Envelope” may be returned by one of the following means:

1. U.S. Mail: Place First Class Letter postage on the ballot return envelope and mail the ballot to County Clerk or Election Commissioner listed on the envelope; or
2. Hand Delivery: Deliver the ballot to the County Clerk or Election Commissioner’s Office at the address listed on the ballot envelope or place it in the designated drop box outside the building if available.

NOTE: All ballots must be in the possession of the County Clerk or Election Commissioner no later than 5:00 p.m. on Election Day, March 11, 2025.
